

Banking and Compliance

Coinsource is a registered money service business (MSB) with the Financial Crime Enforcement Network (FinCEN) a bureau of the United States Department of the Treasury, and as such, is authorized to conduct Bitcoin ATM business in all U.S. states and territories in accordance with the Bank Secrecy Act (BSA) as regulated by the federal government of the United States.

Additional specific state regulations and required licenses differ on a state-by-state basis. Coinsource currently holds 14 required state licenses to conduct Bitcoin ATM business, including the coveted New York State BitLicense, required to operate in the state of New York, and of which only 19 total have been issued in a 4-year period. At the state level, Coinsource is licensed and bonded to conduct Bitcoin ATM business in 40 states, excluding Alaska, Connecticut, Iowa, Kentucky, New Mexico, North Dakota, South Dakota, Vermont, West Virginia, and Wyoming. This has taken more than four years and millions of dollars in legal, compliance, and licensing resources to achieve and maintain.

Serving as a Coinsource agent on their licenses, operators forgo the time and cost required to acquire and maintain the registration and licensing requirements of a money service business and money transmitter in compliance with federal and state laws and regulations. Coinsource allows operators to instantly conduct Bitcoin ATM business in 40 states, in any market of their choosing, while Coinsource takes on the responsibility of maintaining all federal and state registration and licensing requirements including onboarding, monitoring, due diligence, reporting, and audits from financial institutions, law enforcement and state and federal regulators.
